## Terms

Materials and Hire Equipment.

Quotations are accurate when provided, however as we are subject to external changes in the price, we reserve the right to alter the cost, you will be notified of any changes prior to undertaking the work.

Invoices are generated after the works are completed in full unless otherwise agreed, full payment will be required within 28 days of the date of invoicing, after this period a 5% surcharge is applicable and also payable for every additional calendar month where payment has not been received in full.

Goods remain the property of Bicester Tree Services until payment has been received in full, however all liability for goods will pass to the client on delivery.

Where an order has been placed but changes are requested, we reserve the right to pass on costs incurred as a result of those changes, this also applies to cancellations outside of the agreed notification period.

We will not be bound to honour any prices where we have indicated to you subsequently that the prices provided have been in error.

## Quotations

After acceptance of the quotation a 'cooling off period' of 14 days is allowed where no cancellation fee is incurred, unless a date is scheduled to undertake that work within those 14 days at the client's request. If work is cancelled at short notice and we are unable to reschedule other works, you will be charged either 100% of the cancelled work or the difference between your cancelled work and the work we are able to complete for another client.

Conservation area applications. If you are located within a conservation area an application will be submitted at no additional cost, however if you subsequently decide to cancel or omit the intended works a charge of £50+VAT will be invoiced to compensate for the time required to produce and submit the application.

All extra work requested other than that stated within the quotation may be subject to a further charge at our current rates in addition to the quoted price.

Replacement tree selection is subject to availability, we reserve the right to offer a suitable alternative or omit the cost altogether where stock is not available. If you are unable to accept any ordered stock during scheduled works and we are requested to make a redelivery a £40 re-delivery fee may apply.

## Arboricultural Contracting

All work will be completed to British Standards for tree work BS3998 2010, unless otherwise agreed with the client or representative. We will always be as accurate as possible, however measurements specified by us are always approximate.

Nesting birds. When instructing tree work during the bird nesting season you will be made aware of the likelihood of nesting birds being present within the tree or hedge, if there is a high potential for the presence of nesting birds and you choose to go ahead (whether present during the quotation process or not) additional costs associated with returning to finish the specified works may be added to the invoice total.

Underground services. No liability can be accepted for damage to underground services where they are not obvious and we have not been made aware of their presence, any cost incurred will be the client's responsibility.

Subsidence and Heave. We are unable to accept liability for damage which may arise from subsidence or heave as a result of arboricultural operations and are also unable to offer advice on the possible implications of tree roots on buildings.

Tree Preservation Orders. If you are unsure of the presence of TPOs or other statutory reasons which would prevent the work proceeding then we need to be made aware of this prior to quoting. There will be no additional charge for submitting an application to the local authority, but if we are not made aware of the tree protection, the client will be responsible for costs incurred during legal proceedings brought by the authority.

Felling. If contamination is found within the lower stem, the stem will be left as low as possible.
