### 5. Oxfordshire County Council/Cherwell District Council Highways Update

- Sink hole alongside footpath, OCC investigating. Thames Water confirmed not in their ownership.
- Reported missing sign on Church Close and broken sign on Bletchingdon Road. Church Close sign has been ordered and I was told Bletchingdon Road sign had been fixed already which I have informed them it has not.
- Knowle Lane drain issue highlighted by resident again, followed up with OCC.
- Bletchingdon Road vegetation reported for cutting back, chased again prior to March nesting ban but to no avail.
- Knocked over sign on B430 fixed.
- Grip works on rural roads carried out around area I have sent across information on Church Lane/Bletchingdon Road to see if any more measures can be included here.

#### 8. Parish Council Archiving: Oxfordshire History Centre

Parish Council archive documents e.g. meeting minutes, receipt books, village issue correspondence were dropped off to the Oxfordshire History Centre on 27<sup>th</sup> March 2025. These will be reviewed and items not able to be stored by the centre will be returned to the Parish Council (via clerk collection). These documents will then be stored in a cupboard in the Village Hall with existing items.

The Parish Council has full access to the documents and would just need to make an appointment to visit the centre and access them.

### 9. Councillor Vacancy Notice

Cherwell District Council provided a vacancy notice on 10<sup>th</sup> March 2025 following notification of the resignation of Councillor Lanham.

In accordance with the Local Elections Rules an election to fill the vacancy shall be held if, within 14 days after the date of this notice (i.e. no later than 28 March 2025), a request for an election to fill the said vacancy is made in writing to Cherwell District Council by ten electors. In the event that no such request is received by 28 March 2025 the vacancy will be filled by co-option.
